## **Priority for Service (PFS):**

This field indicates that the student had:

- Education Interrupted AND at least one of the following needs:
  - ⇒ ELL
  - ⇒ Retention
  - ⇒ Credit Deficient
  - ⇒ Failed State Tests
  - ⇒ Below Modal Grade
  - ⇒ Low Academic Grades
- In NYS Migrant Education only In School students (grades K-12, UG, DO) can be classified PFS
- At the beginning of a new School Year (September 1st), all these factors need to be reevaluated in order to determine if the student is still PFS
- Periodically provide a list of PFS to tutors and Directors so they can provide appropriate services

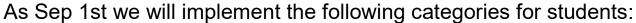

## **Service Intensity Levels:**



- Service Level 3: PFS AND available for Instructional services
- Service Level 2: Non-PFS AND available for Instructional services (includes OS, PK, IS students that are not PFS)
- Service Level 1: Monitoring & support. Student is not receiving instructional service. Student can be PFS or Non-PFS.
- Service Level 0: No contact. Student is not being monitored nor is receiving any type of service from the METS.

## **Preparing Data for Academic Enrollments:**

To enroll eligible students for the 2016 Academic Year:

- 1. Run a list of students that are still in your area and will not lose eligibility before 09/01/16. You can use the following parameters:
  - Depdate is null
  - TermDate>=09/01/16
  - EnrollDate is between 06/24/16-08/31/16
  - Student Ineligible is null
- 2. Follow steps 2-5 provided on the June 2016 Newsletter replacing 09/01/16 instead of 06/24/16.

#### Other things to consider:

- ⇒ You are going to promote grades for In School students (K-12). For example, a 3rd grader enrolled during Summer 2016 will be promoted to 4th grade. This also means changing the School Building Facility accordingly.
- ⇒ Students that dropped out of school during SY2015-16, will be recorded for SY 2016-17 as Grade D+, Still in School=D+
- ⇒ Remember to print a final SY2015-16 list of students for your records
