Non-Migrant Enrollment

This feature was created on MIS2000 for Secondary students that earned Course History and Test information prior to becoming migrant eligible. For an Non-migrant enrollment line you need to enter:

- *School History tab:* Start Date, Withdraw Date, Grade, Still in School
- *Course tab:* All MSIX required data elements
- *Test tab:* All MSIX required data elements
- Important: do not forget to add to any new report the following condition:
SchoolHistory.NONMIGRANT=N

NOTE: Create a non-migrant enrollment line for each grade you are entering course information. Example: if you are entering information for a newly identified 11th grader, you will have two non-migrant enrollment lines for previous test/course work earned in 9th and 10th grade. Each enrollment line will have associated the correct test/course information accordingly.

Graduation Plan:

As of August 29th, 2016 Data Specialists can print the Graduation Plan Part I from Snap report. Please use the following filters:

- ◇ !CurrentScholYearStartDate := 09/01/16
- ◇ Facility.REGIONCODE = Your region code. Ex: 13
- ◇ School History.GRADE is between 09 and 12
- ◇ School History.STILLINSCHOOL= Y
- ◇ Start Date 09/01/16 End Date 08/31/17

NOTE: It will only work for SY16-17 if you already have a 09/01/16 enrollment line

NOTE: We also updated the Student Intake Form– School Year. The OSY Profile and School Year Summary will be available soon.

Service Delivery:

- ◆ A new tab called “Service Del” has been added to the Student side.
- ◆ You will notice that this new tab is unique since it is not associated to an enrollment line but it will require you to specify a Service District. Match the current school district with the Service District.
- ◆ For example: If a 5th grader is enrolled 09/01/16 in Albion CSD, the district on the COE will be Albion CSD, the Service District will be Albion CSD and the facility will be Ronald Sonoma Elementary School.
- ◆ When entering an Intake form, simply click the (+) bottom on Service Del, enter the Service District, date, and level for the student. On this tab you will also enter the tests/forms contained in Section VIII of the Intake form.
