EasyCBM Spring Assessment

Who should be tested during the EasyCBM Spring Assessment Benchmark?


- Any Level 3 student that received a pre-test (Fall or Winter) and ANY instruction on ELA/Math
- Only assess in the target area that student received instruction
- No Instruction=No post-test. If a student did not receive any instruction from MEP staff, you do not need to administer the post-test
- ELL students: If the METS decided to enter a zero (0) as a pre-test based on assessments such as the NYSELAT, the METS is still required to administer a post-test. Directors: for more information, refer to the *English Learners Annual EasyCBM administration* doc
- Data Specialists do not need to enter any EasyCBM tests in MIS2000 since the ID&R Office will export test scores directly

Needs Assessments English Language Learner

NYS MEP tracks how many eligible students are English Language Learners (Limited English Proficiency) in order to assess the needs of students and determine PFS

Grades K-12 and UG– The school is the entity making this determination based on testing results with the NYSITELL & NYSESLAT

Preschool and OSY- METS staff can determine if the student has such need



2017/18 Level 2 Data Reconciliation

- ⇒ The first Level 2 Data Report for 2017/18 Performance Period (PP) was distributed to METS in Mid-March
- ⇒ The second Level 2 Data Report for 2017/18 PP was distributed to METS on May 10, 2018
 - Please add the missing NYSSIDS into MIS2000 and send to ID&R the completed Data Reconciliation Form by 5/31/18
- ⇒ The third Level 2 Data Report for 2017/18 PP will be distributed June 8, 2018
 - You can tell school districts that State Ed will run the report on 06/04/18
 - You will NOT need to call school districts for this report
 - You will need to review the updated report and provide to SED (Kin Chee) the name of any districts that did not respond to your previous contacts by 6/20/18
- ⇒ **IMPORTANT:** The SIRS letters (Ira's memo) will also be sent to school districts in late May, 2018
- ⇒ **IMPORTANT:** When you are done using the data, please delete the Level 2 Data Report from the flash drive and your computer
- ⇒ **IMPORTANT:** In the case that you have a student that appears with a different spelling or different name on the Level 2 Report than your records on MIS2000, please follow our process of making changes to the COEs before making major changes in the student data. Remember, the COE copies that are housed at the METS have to match the COE copies in the ID&R Office

- Updated 17/18 Level 2 Data Reconciliation missing data (review grade, names, and missing NYSSIDSs) entered on MIS2000 by 5/31/18

- Last day to send SIRS letters to school districts is 6/15/18
- Send the Updated Data Reconciliation sheet (with problematic school districts) to SED by 6/20/18
